1. Kamp K-9 agrees to exercise due and reasonable care to keep its premises sanitary and properly enclosed.
2. Kamp K9 does not assume and shall not be held responsible for any liability to the animal listed in this agreement, of any kind, character whatsoever which might arise from the day care of this animal, or any damages which may accrue from any other causes whatsoever. This includes but not limited to, loss by fire, theft, running away, death, injury to persons, animals, or property, or death or injury to any other animals caused by the within named animal during the term of this contract, whether this animal is on the premises of the Kamp K-9 facility or not. The owner of said animals agrees hereby to be and is responsible for any and all acts of behavior or said animal at anytime within the term of this contract. In no way shall Kamp K-9 be in any way responsible. The responsibility and/or liability of Kamp K-9 in no event shall exceed one hundred dollars (\$100.00). The undersigned to limit the responsibility against Kamp K-9 to one hundred dollars (\$100.00) for any and all damages sustained or suffered by reason of the day care of this animal at Kamp K-9 to the sum of one hundred (\$100.00) and no more and agree not to claim any damages against Kamp K-9 of any nature whatsoever, either by way of the contract, negligence or otherwise in excess sum.
3. The owner of the within named animal specifically represents that he/she is the sole owner of said animal and that there is not any lien or mortgage against said animal and that the within named animal has not been exposed to distemper or rabies within the last thirty (30) days and the required annual license has been obtained.
4. Kamp K-9 shall have, and is hereby granted, a lien on the foresaid animal for any and all unpaid day care/or other charges resulting from the day care of said animal with Kamp K-9. The owner hereby agrees that in the event that the daily care charges are not paid within thirty (30) days after they become due and payable in accordance with the term of this contract, Kamp K-9 may exercise its lien rights and ten (10) days after notice may dispose of said animal for any and all unpaid charges at private sale, and owner specifically waives Section 3051 and 3052 of the California Civil Code, and if such sale does not secure a price adequate to pay such cost of day care and/or other charges delinquent plus cost of sale, then owner shall and must pay to Kamp K-9 the difference. Any monies realized by Kamp K-9 at such a sale over and above charges due and cost of the sale shall be returned to the owner. Notice shall be conclusively deemed to have been given pursuant to this paragraph if notice in writing of such intended sale shall be mailed by registered mail to the owner of the within named animal at the address given herein, and no further notice of sale shall be required.
5. If the animal become ill, the owner shall be notified at once, collect if possible, or such attempt shall be made to so notify the owner, and if does not immediately inform Kamp K-9 regarding measures to be taken or if the state of the animals health requires immediate action, the right to call a veterinarian or to administer medicine or to give advisable attention within the situation shall be taken for granted by Kamp K-9, and such expenses being reasonable in amount shall be paid promptly by the owner.
6. Unless owner files with Kamp K-9 within thirty (30) days from the date the animal is removed from Kamp K-9, a written demand for any claimed injury or damages resulting from day care of said animal under this contract, said owner shall and does hereby waive any and all rights which he may have against Kamp K-9 for any liability arising under this contract for damages, or otherwise.
7. The singular, as herein used, means also plural, the masculine gender means also feminine gender. If any word, sentence, or section of this agreement be declared invalid. Such rulings shall furthermore not affect any other word, sentence, or section of this agreement. The remedies hereunder are cumulative to Kamp K-9 and not alternative. No person is bound by any changes therein, concerning the owner of the within named animal. Time is of the essence hereof.
8. If action is instituted by Kamp K-9 in order to enforce this contract, owner promises to pay such sum as the court may fix as attorney's fee.
9. The animal is not to be taken off the premises except by consent of owner.
10. The owner guarantees payment for this bill. If for any reason this bill is not paid when presented, and is placed in the hands of an attorney for collection, the owner agrees that a reasonable fee may be added for attorney's fees and other such costs as the courts may all. Interests charged on overdue bills at the rate of 9%.
11. Kamp K-9 reserves the right to refuse service to any dog for any reason.
12. A \$25 service charge will charged for any returned checks.
